# \*\*\*This informational letter (IL) updates IL 2444-MC-FFS<sup>1</sup>.\*\*\*

lowa Medicaid has limited provider claim submissions during the CPAP rental period. Iowa Medicaid recognizes the national shortage and recall of CPAP machines and has agreed to provide short term approval to allow durable medical equipment (DME) providers to bill for supplies during the CPAP rental period.

Iowa Medicaid will provide short-term coverage of CPAP supplies during the CPAP rental period of April 1, 2023, to June 30, 2023. Iowa Medicaid will re-evaluate the availability of CPAP devices and determine need for continuation of coverage.

The short-term coverage period now includes five additional supply codes. The coverage period remains the same (April 1, 2023, to June 30, 2023). Iowa Medicaid will accept retroactive claims dating to April 1, 2023.

Coverage includes the following supplies/rates:
