The purpose of this informational letter is to announce an Iowa Department of Public Health (IDPH) program that has opened for bids. The CAH and oral health programs funding opportunity (FO) has posted on the Iowa Grants website. This RFP will solicit contractors for the collaborative service areas (CSA) not covered under RFP 58823005. The FO ID number is 478695.

To view, go to <u>lowaGrants.gov</u> and click on 'Grant Opportunities' on the left side of the page. You do not need to log in to view the RFP.

This RFP will enable IDPH to select the applicant most qualified to provide CAH services at the community level. CAH services include Healthy and Well Kids in Iowa (Hawki) outreach, Early ACCESS, Healthy Child Care Iowa (HCCI), and I-Smile™. The I-Smile™ program also includes I-Smile™ @ School.

The project period shall be from January 1, 2023, through September 30, 2026. HHS expects the initial contract period to be a nine-month term from January 1, 2023, to September 30, 2023. HHS shall have at its sole discretion the option of renewing the contract

for up to three (3) additional one (1)-year terms, subject to review of the continuation application, contractor performance and compliance with the terms and conditions of the contract, availability of funds, program modifications, or any other grounds determined by the HHS to be in the department's best interests.

Applicants will be required to select one of the CSAs outlined in the table below and serve all counties within the selected CSA. This RFP is soliciting applications for only those CSAs listed.
