

INFORMATIONAL LETTER NO. 2242-MC-FFS

TO: All Iowa Medicaid Skilled Nursing Facilities and Nursing Facilities

RE: Minimum Data Set (MDS) / Case Mix

EFFECTIVE: Upon Receipt

On December 8, 2020, <u>Informational Letter (IL) 2196-MC-FFS</u>, *Minimum Data Set (MDS) / Case Mix*, was issued. This IL is a reminder to providers of the current process for the extraction of MDS assessment data for case mix and to provide important dates for case mix 2021.

In response to the federal Public Health Emergency (PHE), the Centers for Medicare and Medicaid Services (CMS) released COVID-19 1135 Blanket Waiver on March 1, 2020, that included waiving 42 Code of Federal Regulations (CFR) 483.20 timeframe requirements for completing and transmitting MDS assessments until the end of the PHE.

On April 8, 2021, CMS announced they were ending the emergency blanket waiver of the timeframe requirements for completing and transmitting resident assessment information (MDS) effective May 10, 2021.

The IME is aware that the federal PHE and the federal blanket waiver were extended allowing the extension of the MDS submission due dates. However, in an effort to set rates in a timely manner, per lowa Administrative Code (IAC) 81.6(4), the IME began extracting MDS assessment data from the Quality Improvement Evaluation System (QIES) database in December 2020 for MDS assessment reference dates of April 1, 2020, through June 30, 2020.

The extraction of MDS assessment data is back on schedule for 2021 and the data will be extracted on the specified dates listed in Table 1. The case mix 2021 important dates

are listed in the Iowa Medicaid Portal Access (IMPA) and are located on the DHS website.
