lowa Medicaid announces the release of the 2024 Home and Community-Based Services (HCBS) Provider Quality Self-Assessment. The HCBS Provider Quality Self-Assessment (form 470-4547) can be found on the <a href="lowa Department of Health and Human Services">lowa Department of Health and Human Services</a> (HHS) website<sup>1</sup> and is due January 31, 2025. The form has been updated and prior years' versions will not be accepted.

Organizations should be familiar with ongoing reporting requirements for new and closing HCBS settings as outlined in <u>Informational Letter (IL) No. 2571-MC-FFS</u><sup>2</sup>. As part of the review of the 2024 HCBS Provider Quality Self-Assessment, organizations must work with their HCBS Specialists to verify current, accurate records of all HCBS settings.

HCBS providers of lowa's seven waivers or Habilitation enrolled for any of the following services are required to complete this annual HCBS Provider Quality Self-Assessment:

- Adult Day Care
- Agency Consumer-Directed Attendant Care (CDAC)

- Behavior Programming (Brain Injury Waiver)
- Counseling (AIDS/HIV Waiver)
- Day Habilitation
- Elderly Waiver Case Management

### **Training**

HCBS providers required to submit an annual HCBS Provider Quality Self-Assessment must participate in a recorded webinar available on the <a href="https://example.com/HHS website">HHS website</a><sup>3</sup>. This webinar provides instructions for completing and submitting this required document.

A complete and accurate self-assessment must be received no later than January 31, 2025. Failure to submit by January 31, 2025, will jeopardize an organization's Medicaid enrollment, including managed care contracts, and may result in a sanction of payment suspension.

The Quality Improvement Organization (QIO) HCBS unit will confirm receipt of submitted self-assessments. HCBS Specialists will review submissions and notify the HCBS provider of incomplete or unacceptable submissions. Timely remediation is required for incomplete or unacceptable submissions. Questions about this IL or regarding the 2024 HCBS Provider Quality Self-Assessment should be directed to your organization's assigned <a href="https://hCBS Specialist">HCBS Specialist</a><sup>4</sup>. Specialists are assigned based on the county where the parent agency is located.
