RE:	Federally Qualified Health Centers (FQHC) and Rural Health Clinics (RHC) Rate Floor Update
EFFECTIVE:	January 1, 2025

Informational Letter (IL) No. 1562<sup>1</sup>, issued October 27, 2015, set the rate floor for managed care organization (MCO) payments to Federally Qualified Health Centers (FQHC) and Rural Health Clinics (RHC) at the provider specific Benefits Improvement and Protection Act (BIPA) Prospective Payment System (PPS) rate. The BIPA PPS rates are updated annually using the Medicare Economic Index (MEI) factor.

The MEI factor for 2025 is 3.5 percent. Updated provider specific BIPA PPS rates have been calculated and were provided to the MCOs on November 22, 2024. The updated rates are effective for services on or after **January 1, 2025**.
