RE: SFY27 Home and Community-Based Services (HCBS) Waiver Rate Changes

EFFECTIVE: October 01, 2026

Provisions of the 2026 House File 2782, Division VI. Section 15. appropriated \$3.0 M to implement an increase to specific Home and Community-Based Services (HCBS) Waiver service reimbursement rates for services most used by Elderly Waiver participants.

For the HCBS Waiver services listed in the table below the reimbursement rates have been increased to the rates listed effective October 1, 2026.
