#### II. IDENTIFY THE AREAS OBSERVED ON THE VISIT:

This program is located in the Community Y Cultural Building. There are no rec programs held in this building during the hours of child care. There are two separate programs offered. The preschool program is offered year round for children ages three to five. They are in their own enclosed classroom space.

School age care is also offered year round, and these children primarily use the gym. There are also two other rooms that are utilized. Due to the interest for school age children to attend the summer program, the capacity for them is being increased from 70 to 120. During the school year they only provide care after school from 3:45-5:30. There is no before school care offered.

Ashley Woodruff is the director over the child care programs. She has an AA degree in Child development. She worked in a child care center for two years before starting to work at the Y Preschool program. In 2008 she was promoted to director.

Robbie Tobias is the on-site supervisor for the school age program. He has a BS degree in Physical Education. He worked one year for the school district before starting to work for the Y in 2014. In 2016 he was promoted to the school age site supervisor.

# III. IDENTIFY THE OBSERVED STRENGTHS OF THE CENTER:

The Y program has grown and expanded since Ashley became the director in 2008. The preschool program is now offered year round, and the school age program is now licensed by DHS. Ashley oversees both programs and is frequently in the classrooms and the children know her by name.

These programs are able to use other programs offered through the Y such as swimming, dance, and a program called Strong Kids. They offer a fun environment and their enrollment has grown due to word of mouth.

Most of the staff working with the school age children are going into Elementary Education at college.
