The preschool also has access to other rooms nearby this classroom, where snack is served. The preschool serves children ages three and four years of age. Mary Catherine Striegel is the director/lead teacher. Mary Catherine has an Associates of Arts degree in Sign Language. She has many years of experience working with young children in the school setting as well as child care setting. Mary Catherine began working at the preschool in 2016.

An unannounced visit was completed on today's date. Mary Catherine was working today along with the assistant teacher. There were seven children present today.
