### II. IDENTIFY THE AREAS OBSERVED ON THE VISIT:

On 7/3/17 I made an unannounced licensing visit to Kiki's Kids Learning Center and Preschool and met with Director/Owner Nicole Fraise. The site is newly constructed and is located in a rural area between West Point, Franklin and Donnellson, Iowa. The center is located on a gravel road and around the center are three houses. Nicole's residence is is adjacent to the center and grandparents are also next to the center. Nicole Fraise is the Owner/Director and has a AA in Early Childhood Education. She has ten years' experience working in licensed centers and had her own in home daycare across the street from the facility for two years. The center also has an onsite supervisor Jessica Bohnenkamp. She has education classes, but not yet finished her degree. She has 4 years of experience in child care. Jessica also has been employed at the center since it's opening and prior to that worked in Nikki's home providing care. This is the center's 3rd year of operation.

On the visit all program areas were observed.

  Number not in compliance: 3 Staff files were not complete including staff physicals, mandatory reporter training, essentials training and universal precautions.
- 2. 109.11(3)a: Center shall ensure that: Facility and premises are sanitary, safe, and hazard free. Adequate indoor and outdoor space is provided. The outdoor area shall include safe play equipment and area of shade. Sufficient space provided for dining. Sufficient lighting shall be provided. Sufficient ventilation. Sufficient heating. sufficient cooling. Sufficient bathroom and diapering facilities. Equipment, including kitchen appliances, are maintained so as not to result in burns, shock, or injury to children. Sanitation and safety procedures for the center are developed and implemented to reduce risk or injury or harm to children and reduce transmission of disease. Food waste containers must have a lid. The outdoor play area fence is loose on the bottom. Cots should be spaced at least 2 feet apart. Cleaners should not be accessible to children.
