#### II. IDENTIFY THE AREAS OBSERVED ON THE VISIT:

Visited center on 09-05-19 and spoke with Jane Heider, Director. Ms Heider has a 4 year degree, is a Para educator and has 41 years of experience in childcare. Mary Elizabeth Daycare was the first daycare center built in the area and has been in operation since 1914. The physical facility appears to be well maintained. The center has 5 rooms - a dining area/school age, preschool room on the second floor, 2 year olds, large motor room and a room for three year olds. The center operates Monday through Friday 6am to 5:45pm. The center serves children ages 2 years to school age. Currently there are 69 children enrolled in the program, and 25 present at the time of the visit.

The center has the following areas throughout the rooms for the children to explore and learn: toys, books, legos and house. Sufficient amount of toys and equipment for this rooms. Children have access to a bathroom and sink. Daily schedule of activities was posted. Child size furniture throughout the rooms.

The center's goals are updating their building. The center is getting new kitchen counter-tops, updating the playground, and painting the inside of the building. The center has had several new staff and is working on retention with staff meetings more often. The director would also like staff to get more training. The center uses a company that comes and does the laundering of the children's cot sheets and blankets weekly. They also recently received a grant for 300 bags of mulch for their playground.

## III. IDENTIFY THE OBSERVED STRENGTHS OF THE CENTER:

The center has added security to the front door whereby parents need a pass code or staff let them into the center.

The center sends home a monthly newsletter for the parents.

The center has a QRS rating of 4 stars.

Staff interact with the children in a positive manner.

Center has new board members.

Center is updating one bathrooms.

Center recently started a new software - Procare
