Summary of Complaint:			
Concerns reported that Beverly left an infant in a vehicle and children playing in a park across the street with an unapproved individual. Beverly was going to the school to pick up children from school for a parent and left the children under the supervision of her teenage daughter who is not approved as an assistant or a substitute within the child development home.

Code of Iowa, Chapter 237A
441 Iowa Administrative Code Chapter 110

441 IAC 110.7(1)The provider meets the following requirements: a. Gives careful supervision at all times. b. Frequently exchanges information with the parent of each child to enhance the quality of care. c. Gives consistent, dependable care. Is capable of handling emergencies. d. Is present at all times, except if emergencies occur or an absence is planned. If absence is planned, care is provided by a HHS-approved assistant. If absence is planned, the parents are given at least 24 hour prior notice.

441 IAC 110.7(2)Substitutes. The provider shall assume responsibility for providing adequate and appropriate supervision at all times when children are in attendance. Any designated substitute shall have the same responsibility for providing adequate and appropriate supervision. Ultimate responsibility for supervision shall be with the provider.

441 IAC 110.9(2) Assistants

Documentation from the Department confirming record checks have been completed and authorizing or limiting the person's involvement with child care.

This worker visited Beverly's child development home unannounced on 9/24/2025. HHS worker Melissa Housinga accompanied this worker. The concerns were discussed with Beverly. Beverly stated that she went to pick up children at Fillmore School. Beverly reported that she had five children in the car, including the infant. Beverly's 16 year old daughter was also in the vehicle. Beverly stated that there is a park across from Fillmore School and she allowed the four preschool children to play in the park and left the infant sleeping in the car. Beverly had her teenage daughter sitting outside positioned between the vehicle with the infant sleeping (windows down and doors locked) and the children playing in the park. Beverly proceeded to go to Fillmore to pick up a few kids. Beverly believed it took her approximately 10 minutes or less to walk across the street and get the children. The children's mother was running late and meeting Beverly at the park to pick up her kids. Beverly did not have enough car restraints for the additional children should she have needed to transport them.

Beverly admitted to placing her teenage daughter in a caretaker role while she went across the street to get the children from school. Beverly's daughter is not an approved assistant in the child development home. In order to be left alone with children, an approved substitute aged 18 or older should have been present with the children. Beverly further acknowledged that she should have said no to the parent who needed their children picked up or she should have walked all of the children with her.

Findings:

Beverly admitted that she left a sleeping infant in a vehicle and several preschool children in the park playing while she walked across the street to pick up children. Beverly had her teenage daughter who is not approved to be alone with children in charge of all of the children.

Resolution and Action Required:

A safety plan was completed with Beverly on 9/24/2025. Beverly agreed that she will provide eyes and ear supervision to all children at all times. Beverly will not allow unapproved persons to care for day care children. Beverly will only transport children if she has enough safety restraints for all children. Beverly will call 866-448-4605 to add assistants or substitutes for her child development home. Assistants and subs can not be used until authorized by HHS.
