Dear Child Care Provider:

This letter is in regards to the compliance visit at your Registered Child Development Home C conducted on 07/15/2020. lowa Code Chapter 237A and 441 lowa Administrative Code, Chapter 110, describes specific requirements that must be met by a Registered Child Development Home. Your home is rated a 4 on the voluntary Quality Rating and Improvement System. The following areas were out of compliance at the time of the visit:

441 IAC 110.9 Files

441 IAC 110.9(1) A provider file is maintained and shall contain the following:

441 IAC 110.9(1)" a"

A physician's examination report for the provider and all members of the provider's household aged 18 years or older. Acceptable physical examinations shall be documented on Form 470-5152, Child Care Provider Physical Examination Report. All children residing in the household must have medical documentation outlined in 110.9(4) "d", 110.9(4) "f", and 110.9(4) "g"

Findings:

This compliance visit occurred at about 3:30pm on 7/15/2020. The provider had six children in care. None of these children were under 24 months. The provider states that she takes the temperatures of each child and hand sanitizes each child as they enter her program to protect against Covid. The provider provides care on the first floor of her home and has it set up similar to a preschool. She has years of experience as child care provider at centers.

The provider needs to have an updated physical for herself and her husband. She stated that she had an appointment scheduled in March but it was cancelled due to covid. She was recently told by her doctor's office that they are not able to get in for physicals until December and has appointments scheduled at that time.
