Nina (Karyn) has been providing childcare in her home for 17 years. She reported that she has utilized a preschool program called Fireflies, but in the last few years, she has let the children learn by play. Nina reported that she always has a list of activities for the children to complete and right now they try to be outside as much as possible.

2. Identify Observed Strengths Of The Program

While compliance staff visited with the provider, it was observed that she is very in tune with the children. She addressed the children as they had needs or wants. Compliance staff could see areas in the childcare where the children have completed their artwork and it is displayed. The provider has ABC's and numbers on the walls and these have differing colors. Children have different learning opportunities.

******The provider self-reported that she has not been documenting her monthly efforts. The provider was given a clean sheet to make copies from for her future use.
