Summary of Complaint:

On 8/8/19 the Department of Human Services received a complaint regarding registered category B child development home provider Sara Weltha. The complaint alleges Ms. Weltha has allowed a 14 year old relative to move into the home with her. Ms. Weltha has not contacted registration.

Rule Basis and Findings of Complaint(s):**RULE(S):**

441 IAC 110.9(1)"b"(2) Documentation from the department confirming the record checks required under 441 IAC 110.11(3) have been completed and authorizing or conditionally limiting the person's involvement with child care.

FINDING(S):

I completed an unannounced visit on 8/13/19 to Ms. Weltha's daycare residence. Ms. Weltha allowed entrance to discuss the complaint and was cooperative. I reviewed the concerns regarding a 14 year old relative who moved into the home and needed to notify registration immediately. Ms. Weltha identified an emergency family situation and is unsure how long this child will be residing with her. On 9/5/19 this worker spoke to Ms. Weltha. She reported the child is with her and she has the paperwork to add the individual to the household. Ms. Weltha will contact this worker once all the paperwork has been turned into registration.

Resolution and Action Required:

A full compliance visit was completed. Minor corrective actions were necessary at this time, unrelated to the current complaint. This report concludes the evaluation of this complaint; no further action is required at this time.
