Concerns reported that Savanna has an unapproved individual residing in her home. Additional concern that this unapproved individual has watched child care children.

Rule Basis and Findings of Complaint(s):

Code of Iowa, Chapter 237A
 441 Iowa Administrative Code Chapter 110
 441 IAC 110.9(2)a. Assistants. Documentation from the Department confirming record checks have been completed and authorizing or limiting the person's involvement with child care.
 441 IAC 110.9(3)a. Substitutes. Documentation from the Department confirming record checks have been completed and authorizing or limiting the person's involvement with child care.

HHS Huinker attempted two unannounced visits to Savanna's child development home and no one answered the door 1/12/26 and 1/13/26. Messages were left for Savanna to call. On 1/13/2026 Savanna left a message for this worker to call with a new phone number. This worker completed a home visit on 1/15/2026. Savanna was home and did not have any child care children present at the time of the visit. Savanna stated that her mother has been living with her on and off since April 2025. Savanna stated that she spends the night occasionally, however, does not care for children. Discussed with Savanna that her mother recently answered the phone and stated that she resided in the home. Children were heard in the background. Savanna was not aware of when this was, but stated her mother does not watch her day care children ever. HHS Huinker discussed with Savanna that additional household members need to be reported to the Child Care Unit within 10 days. Savanna stated that she wasn't really 'living' with her, but staying occasionally. Discussed that spending the night regularly implies residence and therefore needs to be reported and appropriate background checks completed. Savanna stated that she would tell her mother that she can no longer stay with her effective immediately. Savanna stated that she has five other siblings where the mother can go if needed. Savanna understands that background checks are required should she choose to allow her mother back into her home at any point. A safety plan was completed with Savanna on this date that stated Savanna would only allow approved individuals to reside in her home, only approved assistants/substitutes will be allowed to care for children, and her mother will no longer be in the home. Savanna will call the CCA Unit to request paperwork for anyone she wants to reside in the home or work as an assistant or substitute.

Findings:

There is information to support the concern that Savanna had an unapproved individual residing in her home.
 There is not information to support that this unapproved individual ever cared for any child care children.

Resolution and Action Required:

A safety plan was completed with Savanna on 1/15/2026. Random drop in visits will occur to ensure plan is being followed.
 A full compliance visit was also completed on this date. Savanna will submit required noncompliant items to HHS Huinker by the requested date on her compliance letter.
