II. IDENTIFY THE AREAS OBSERVED ON THE VISIT:

This consultant made an unannounced off year licensing visit to Missouri Valley Head Start on 10-8-2020. Shannon Benjamin began working for Head Start in January 2020. The program is located in a one story building that also houses school district administrative offices. There are five children enrolled in the program. The program provides preschool services during the school year from 8:30 am to 12:30 pm on Mondays and 8:30 am to 3:00 pm Tuesday through Friday.

The center closed in March 2020 and reopened on 9-1-2020 due to the Covid 19 pandemic. The center follows the daily Covid 19 recommendations i.e. temperature taking.

Observation of room:

The program moved to their new room in the 2020 (They were previously in this program room a couple years ago). The children were eating lunch. There were five children and two staff present. The staff had excellent interactions with the children

The center is using Creative Curriculum and Teaching Strategies Gold. The lesson plans looked great and they are currently working on the study of pets.

Nutrition:

Breakfast, lunch and snack are provided each day (breakfast and snack on Mondays), the food is catered from Treat America/Company Kitchen. The monthly menus are posted.

Health and Safety:

Monthly fire/tornado drills are practiced and documented.

Radon testing was done in December 2019, with a test score of 0.4 pCi/L.

Playground:

The center has a fenced playground area. Monthly playground safety checks are documented.

Transportation:

The center doesn't provide daily transportation.

Administration records:

The children's emergency medical contact information was reviewed and was in excellent order.

Staff files were read on a previous date and were in excellent order.

Staff had excellent interactions with the children. The center receives excellent community support.
