Kay has been a registered childcare provider since February 2005. Kay is a category C1 provider and she does not have any assistants or substitutes. Kay's childcare hours are 7:00pm to 4:30pm Monday through Thursday and 7:00am to 4:00pm on Friday. Kay cares for children ages 0 to 4 years.

2. Identify Observed Strengths Of The Program

At the time of the compliance visit, Kay was caring for 5 children. The children were observed watching a t.v. show while Kay prepared lunch (sandwiches, green beans and strawberries). Before eating the children prayed. Kay was also observed redirecting some children by kneeling down and speaking with them calmly but directly.

Kay says that she loves the children she cares for and she teaches them respect and manners. Kay uses the Playing Preschool curriculum during the school year which teaches the children numbers, shapes, letters and colors. Kay recently worked with a child on cutting with scissors because he was struggling to learn that skill. Kay has the children say the Pledge of Allegiance daily before circle time.
