II. IDENTIFY THE AREAS OBSERVED ON THE VISIT:

An unannounced visit was completed on 4/9/2019. All programming space was observed. The center was in ratio.

The center's approved fire inspection was completed on 6/13/17.

The director is Holly Bright. Holly has worked in childcare since 2004.

The onsite supervisor is Rileigh Willms. She started in 9/18.

The center provides child care for 61 children.

The center is located inside of a commercial building designed for child care.

III. IDENTIFY THE OBSERVED STRENGTHS OF THE CENTER:

-The center installed new tiling in the kitchen/dining area.

-The center offers preschool and before/after school care.

-The center is working on their playground.

-They go on a lot of field trips during the summer. They go swimming and to the library weekly.

IV. IDENTIFY THE ASPECTS OF OPERATION THAT FALL BELOW THE STANDARDS REVIEWED:
