II. IDENTIFY THE AREAS OBSERVED ON THE VISIT:

An unannounced visit was made to the Project Youth Jungle Kidz program on 05-20-19 where I met with center onsite supervisor Julie Van De Kamp and Director. Amanda has been the director of a sister program, Project Youth Daycare Generations, and Generations 2, since 2013 and has a 4 year degree in early childhood care and education. Amanda is executive director overseeing the operation of all 3 programs.. The program is located in the lower level of the Faith Reformed Church. There are currently 45 children enrolled in the center. All areas of the program were reviewed during this visit.

The center was observed to be clean with no safety concerns noted due to maintenance. The center was working to expand the outdoor play ground area, however, this did not go through and part of that was to add shade. The center needs to provide shade for the playground.

The center has the following areas throughout the rooms for the children to explore and learn: books, blocks, toys, puzzles, art and kitchen. Sufficient amount of toys and equipment for the number of children. Children have access to bathroom and sinks. Displayed throughout the room were children's art work, alphabet, shapes and numbers.

Observed staff playing with the children throughout the day, assisting children with activities, sitting at tables with the children during meals, encouraging children to eat and reading stories to the children. S

In reviewing classrooms each had a variety of toys and materials that were generally appropriate to the ages of the children present.

Since the program is in the lower level of the church the center has provided sufficient illumination to be able to observe the children sleeping.

III. IDENTIFY THE OBSERVED STRENGTHS OF THE CENTER:

The center continues working to make several changes and improvements to the program. The playground was to be expanded but did not go through. However, the center needs to provide shade on the playground. Center is almost done with getting back on QRS.

The center is fun raising and doing an online auction for operations for a new building site. Center has monthly meetings with staff.

Center is working hard with communication with parents, via facebook, and a phone app.
