Compliance staff received a concern that the provider had unapproved people at her home. The concern also noted that the provider is using marijuana.

Compliance staff completed an unannounced visit to the childcare home of the provider. On the date of the visit, the home was dark. The provider reported that she did not have any children in care on this date. Compliance staff discussed the reason for the visit to the home.

The provider talked with compliance staff that there is no one staying in her home besides herself and her two children. She also reported that no one really stops by to see her. It is a rare occurrence that anyone comes by her home. We talked about the difference between someone stopping by and a regular visitor. The provider reported that no one stops by and stays for any long period of time.

The provider admitted to smoking marijuana in the evenings or weekends when childcare is not in session. She reported that it happens more than once during the week. The provider stated that any use is outside of childcare hours and does not effect her ability to care for children.

Compliance staff sought supervision assistance for this situation. After discussion, it was decided that a safety plan would be completed with the provider.

Rule Basis and Findings of Complaint(s):

110.7(1)e Shall be free of the use of illegal drugs and shall not be under the influence of alcohol or of any prescription or non-prescription drug that could impair their ability to give careful supervision.

** The provider freely admitted to use a couple times a week outside of childcare hours. Compliance staff discussed the situation with SWS Aunspach and it was decided that a safety plan would be written with the provider.

The safety plan identifies that the provider will not consume marijuana or any similar items within 8 hours before contact with children that come to her childcare.

110.8 Conditions of the home shall be safe, sanitary and free from hazard.

The safety plan identifies that the provider will not have marijuana or any related products stored in her home at any time.

Resolution and Action Required:

There are no changes needed at this time. The provider agrees to follow the safety plan to maintain her childcare business.
