Summary of Complaint:

On 4/16/2019, a complainant reported staff Ellie was observed picking up a school-age child and placing the child into a large blue recycling bin. The complainant reported Ellie then closed the lid and walked away. The complainant reported being concerned the child may have been injured and was not supervised. The complainant also reported knowing Ellie has done this before to other childcare children.

Licensing Rules Relevant to the Complaint:

109.10(16)a The center and supervisor shall ensure that staff knows names and number of children assigned. Staff shall provide careful supervision.

Inspection Findings:

Licensing conducted an unannounced visit to Kids Inc - Longfellow on 4/17/2019. The following is based upon a face-to-face interview with on-site supervisor Elizabeth "Ellie" Heck, a review of administrative items, and observations while on-site:

109.10(16)a Staff shall provide careful supervision. RULE NOT VIOLATED. IT SHALL BE NOTED, HOWEVER, STAFF ENGAGED IN UNPROFESSIONAL BEHAVIOR.

- Ellie discussed a group game the children and staff play called "Chase and Catch". Ellie reported during this game, she "scoops" kids up and they respond by saying "I hope you don't throw me away". Ellie stated she then places the child she catches in the blue recyclable bin sometimes closing the lid.
- Ellie reported on 4/12/2019, the child she placed in the bin was a 1st grader. Ellie talked about how the child was laughing and saying it was funny the whole time.
- Licensing observed there to be two blue recyclable bins located just outside the school cafeteria/gymnasium where the childcare's primary space is located. The bins appear to be approximately 3-feet in height.
- Ellie reported all the children have fun playing the game and think it's funny when she catches one of them and places one of them in the bin. Ellie denied that any child has reported being scared or injured by the game. Ellie discussed how she also does not intend to harm anyone and/or make anyone upset during the game.
- Ellie discussed how she became aware that someone was upset with the game because the Marion Police Department came to the site on 4/12/2019 after having received a call about it. Ellie said she told the police the same thing she reported to licensing including that it was part of a game. Ellie denied there is any open police investigation.
- Ellie reported since this incident, she participated in a meeting with Kids Inc management including the owner Becky McNeal, multi-site school-age coordinator and Kids Inc - Marion director Chris Hale on the morning of 4/16/2019. Ellie talked about how the meeting included a conversation regarding staff professionalism, on-site supervisor conduct, and Kids Inc policies and procedures.
- Ellie reported she now understands how it was "not the greatest game", how she "made a bad choice" in playing it, and moving forward she will select different group games.
- Ellie stated "Chase and Catch" will no longer be played and children will not longer be placed into any bins.
- Ellie denied that any families/children have stopped attending the program due to the game or the incident.
- A written incident report dated 4/15/2019 was observed in the child's file and reviewed by licensing.
