Dear Child Care Provider:

This letter is in regards to the follow up at your Registered Child Development Home B conducted on 01/08/2019. Iowa Code Chapter 237A and 441 Iowa Administrative Code, Chapter 110, describes specific requirements that must be met by a Registered Child Development Home. You are not a participant in the voluntary Quality Rating and Improvement System. The following areas were out of compliance at the time of the visit:

441 IAC 110.9

Files

441 IAC 110.9(1)

A provider file is maintained and shall contain the following:

441 IAC 110.9(4)

Children's Files. An individual file for each child shall be maintained and updated annually or when the provider becomes aware of changes. The file shall contain:

- **a.** Identifying information including, at a minimum, the child's name, birth date, parent's name, address, telephone number, special needs of the child, and the parent's work address and telephone number.
- **b.** Emergency information including, at a minimum, where the parent can be reached, the name, street address, city and telephone number of the child's regular source of health care, and the name, telephone number, and relationship to the child of another adult available in case of emergency.
- **c.** A signed medical consent from the parent authorizing emergency treatment.
- **d.** An admission physical examination report signed by a licensed physician or designee in a clinic supervised by a licensed physician
 - **1.** The date of the physical examination shall not be more than 12 months before the child's first day of attendance at the child development home.
 - **2.** The written report shall include past health history, status of present health, allergies and restrictive conditions, and recommendations for continued care when necessary.
 - **3.** For a child who is five years of age or older and enrolled in school, a statement of health status signed by the parent or legal guardian may be substituted for the physical examination report.
 - **4.** The examination report or statement of health status shall be on file before the child's first day of care
- **e.** For children under the age of 6,a statement of health condition signed by a physician or designee submitted annually from the date of the admission physical. For a child who is enrolled in school, a statement of health status signed by the parent or legal guardian may be substituted for the physician statement.
- **f.** For each school-age child, on the first day of attendance, documentation of a physical examination that was completed at the time of school enrollment or since.

- **g.** A signed and dated immunization certificate provided by the state department of public health. For the school-age child, a copy of the most recent immunization record shall be acceptable.
- **h.** For any child with allergies, a written emergency plan in the case of an allergic reaction. A copy of this information shall accompany the child if the child leaves the premises.
- i. Documentation that is signed by the parent and names persons authorized to pick up the child. The authorization shall include the name, telephone number, and relationship of the authorized person to the child.
- **j.** Written permission from the parent for the child to attend activities away from the child development home.**k.** Injury report forms documenting injuries requiring first aid or medical care
- **I.** If the child meets the definition of homelessness as defined by section 725(2) of the McKinney-Vento Homeless Education Assistance Act, the family shall receive a 60-day grace period to obtain medical documentation.

Findings:

Lisa Hilsenbeck, Child Care Compliance Auditor, completed a follow up visit on 1/8/19 checking the following regulations:

441 IAC 110.7(2) Terri utilized 25.95 substitute hours for October 2018 and was .95 hours over her allowed amount to use. Viewed substitute hours for December. Terri was within her 25 allowable hours.

441 IAC 110.8(1)"h" Terri needs to repair or replace her smoke detector in her dining room area that will not test. Smoke detector in the dining room was tested during the follow up visit. Smoke detector functioned properly.
441 IAC 110.8(2) "a" Terri needs to cover her grill, remove rake from her outdoor play area and remove big fallen branches from the area. Viewed outdoor play area. Grill, rake and fallen branches have been removed.

441 IAC 110.9(3) Terri needs to show documentation of current course completion of Mandatory Reporter Training for Child Abuse for

Jade, Joy and Tara. Viewed documentation of current course completion of Mandatory Reporter Training for Child Abuse for

Tara. Terri reports Jade and Joy are no longer active.

Terri needs to show documentation of current course completion of First Aid/CPR for Jade, Joy and Tara. Viewed documentation of current course completion of First Aid/CPR for Tara. Terri reports Jade and Joy are no longer active. Terri needs to show documentation of current course completion for Health and Safety Training for Jade, Joy and Tara. Viewed documentation of current course completion for Health and Safety Training for Tara. Terri reports Jade and Joy are no longer active.

441 IAC 110.9(4) Children's Files. An individual file for each child shall be maintained and updated annually or when the provider becomes aware of changes. The file shall contain:

Identifying information including, at a minimum, the child's name, birth date, parent's name, address, telephone number, special needs of the child, and the parent's work address and telephone number. Need update for L.E. Viewed update for LE.

Emergency information including, at a minimum, where the parent can be reached, the name, street address, city and telephone number of the child's regular source of health care, and the name, telephone number, and relationship to the child of another adult available in case of emergency. Need for H.S. Viewed for H.S.

An admission physical examination report signed by a licensed physician or designee in a clinic supervised by a licensed physician

The date of the physical examination shall not be more than 12 months before the child's first day of attendance at the child development home.

The written report shall include past health history, status of present health, allergies and restrictive conditions, and recommendations for continued care when necessary. Need physical for H.S., B.B.(12 mos), J.H. Viewed for H.S., B.B. (12 months). Terri reports J.H. is no longer enrolled in care.

A statement of health condition signed by a physician or designee submitted annually from the date of the admission physical. For a child who is five years of age or older and enrolled in school, a statement of health status signed by the parent or legal guardian may be substituted for the physician statement. Need updated school-aged health status for J.T.(8). Viewed updated school-aged health status for J.T.(8).

A signed and dated immunization certificate provided by the state department of public health. For the school-age child, a copy of the most recent immunization record shall be acceptable. Need for B.B.(12 mos), J.H. Need signature and date on form for J.T.(7). Viewed for B.B. (12 months). Terri reports J.H. is no longer enrolled in care.

A list that is signed by the parent and names persons authorized to pick up the child. The authorization shall include the name, telephone number, and relationship of the authorized person to the child. Need for B.B.(4), K.E. Need update for L.E. Viewed for B.B.(4). Viewed update for L.E. Terri reports K.E. is no longer enrolled in care.

Written permission from the parent for the child to attend activities away from the child development home. Need update for J.T.(7) Viewed update for J.T.(7).

Items of non-compliance after the follow up visit:

441 IAC 110.9(4) Children's Files

Terri needs a signature and date on the immunization record for J.T.(7).

It is essential you correct all above-mentioned violations.
