1. Basic Overview

A compliance visit was conducted on 3/25/26 at Tonya Hansen's level B registered child development home. As a level B, Tonya is able to have 8 full time children with an additional 4 school aged children for 2 hours or less without an assistant present. Tonya has two approved assistants, Alexis and Kalei. Tonya has been providing care to families for 24 year, 23 being registered with the state. Tonya is an IQ4K (Quality Rating) level 2. She is Child Net certified and participates in the Child and Adult Care Food Program, ensuring she is providing healthy and nutritious snacks and meals. Tonya uses the Playground CCMS app for families. Tonya has a learn to play program. Tonya accepts state child care assistance.

2. Identify Observed Strengths Of The Program

Tonya has a plethora of experience. This allows her to have a good understanding of children's emotions and behaviors. As an IQ4K level 2, she has gone above and beyond with extra trainings, policies and safety measures. Tonya describes some strengths are that they are family oriented and treat the children as their own.

3. Identify The Aspects That Fall Below The Standard

Fire and tornado drills are practiced monthly and documentation kept on file for the current year and previous year. Tonya was not able to open the app to show her drills.

Within six months of becoming registered, children 18 years of age or younger residing in the household must have: Admission physical exam report. Immunization certificate. For school age: Documentation of physical exam completed at time of school enrollment or since that time. Physicals need to be updated and put in files.
