#### Summary of Complaint:

Concerns reported that Sharesa billed for more than her allowed capacity for a category B child development home during the time period of 10/27/25-11/9/2025. Billing reflects that she billed for 13 children on a few occasions during that billing cycle.

**Rule Basis and Findings of Complaint(s):**

Code of Iowa, Chapter 237A  
441 Iowa Administrative Code Chapter 110  
441 IAC 110.6 No more children are in care than the number authorized on the registration certificate.  
441 IAC 110.1(1)a. Not more than eight preschool children present at any one time including infants. b. Of these 8 children, not more than 4 children who are 24 months of age or younger are present at any one time. c. Not more than four additional school age children.

This worker stopped by unannounced to Sharesa's child development home on 12/17/2025 during the time Sharesa has typically been over numbers by one child. Sharesa was present and had only 3 children in care. Discussed the concern with Sharesa regarding billing for 13 children on a few separate occasions during the billing period of 10/27/25 -11/9/2025. Sharesa has had this same concern a few months ago and at that time stated it was a billing error because she watches her numbers closely. Sharesa again stated that this was a billing error. Sharesa stated she cares for all state-assisted families at this time and does not currently have any private pay families. Sharesa provides care for all three shifts. Sharesa stated she does have at least one family that she provides care to as well as another provider. Sharesa stated there may have been a billing issue regarding that. Sharesa did contact the CCA Unit to discuss her over billing. It appears the days Sharesa did bill incorrectly which caused the over numbers. Sharesa reported that she has a family that is in care from approximately midnight until 6:30 a.m. Sharesa reported that for one of the children in that family she billed correctly and for the other, she entered midnight until 6:30 p.m., rather than a.m. Discussed with Sharesa the need for her to watch her numbers and billing closely since this has been a repeated concern.

**Findings:**

There is evidence to support the concern that Sharesa billed for more children than her certificate allows. This is shown through Sharesa's own billing records that she submitted to the Child Care Assistance Unit for the billing period of 10/27/25-11/9/2025.

**Resolution and Action Required:**

No further action is required.
